Under section 51 of the Stock (Cattle Tick) Notice 2005

If there are more than two (2) Nominees an additional Application and Agreement must be completed.

Schedule of Conditions

- 1 The Organisation must, at all times during its accreditation with the Queensland Department of Primary Industries & Fisheries ("DPI&F") be:
 - a. a recognised club, association or society under the Associations Incorporation Act ("Organisation") 1981 (Qld); and
 - b. covered by a public liability policy with a reputable insurer for a minimum of \$10,000,000.00.
- 2 The Organisation must immediately inform the DPI&F if there are any changes the Organisation is aware (or ought to be aware of) concerning:
 - a. the status of the organisation that may affect its eligibility to be accredited with the DPI&F;
 - b. the status of its public liability policy should the cover be less than \$10,000,000.00; and
 - c. the cessation of the ATCP's membership with the Organisation.
- 3 All ATCP must:
 - a. be registered in the Agricultural Property System (APS);
 - b. if the property is an infected property in a Queensland free or control zone, the property must be undergoing an approved program for cattle ticks;
 - c. not have had an approval in any approved scheme cancelled for any noncompliance with a condition of the approved scheme or of any travel permit issued in accordance with an approved scheme in the 2 years immediately preceding this Application and Agreement;
 - d. successfully complete the ATCP Instruction and Awareness course; and
 - e. member of an DPI&F accredited Organisation.

- 4 To remove any doubt, for a person to be eligible to be an ATCP, there must be an Organisation (accredited with the DPI&F) nominating that person. If an Organisation's accreditation is cancelled after the person is approved as an ATCP, the person approved as an ATCP automatically ceases to be an ATCP.
- 5 All stock that is to be moved under this scheme must be free of tick.
- 6 The scheme applies to:
 - a. the movement of manageable, groomed stock including both primary (cattle, deer & buffalo) and secondary host species (camelids, donkeys, goats, horses, mules and sheep); and
 - b. the movement is a direct conveyance between properties in the Queensland free or control zones for travel to and return from scheduled competition events held at venues in the Queensland infected zone or in the Queensland free or control zones determined as infected status or at risk (high) status.
- 7 All tick treatments must be performed in a manner approved by an Inspector appointed under the *Stock Act 1915* ("Inspector") using approved equipment and approved chemicals (eg acaricide), as detailed at the ATCP Instruction and Awareness course and in the associated manual. An Inspector may request an inspection of and a demonstration by the ATCP of any such spray equipment and acaricide (or application of it).

Approved acaricide for:

- a. horses, mules and donkeys are Barricade 'S, Blockade 'S or Bayticol Dip & Spray; and
- all other species is amitraz products of Amitik EC Cattle and Pig Spray, Taktic EC Acaricidal Spray for Cattle & Pigs, Amitraz EC Cattle and Pig Spray, Amitik Cattle Dip and Spray, Taktic WP Cattle Dip and Spray, Tickoff WP Cattle Tickicide.
- 8 The ATCP's rights in this Application and Agreement are personal and not transferable. The ATCP must immediately notify an Inspector of any change in circumstances relating to Application and Agreement.
- 9 If, at anytime the ATCP is no longer a member of the Organisation or the person cannot perform the duties of an ATCP, any approval granted will be cancelled.
- 10 If any stock presented for treatment to the ATCP, ticks are found or suspected to be present, the ATCP must:
 - a. notify the nearest Inspector within 24 hours of finding or suspecting the presence of cattle ticks;

- b. not treat or certify any treatment of tick infected (or suspected to be tick infected) stock unless authorised by an Inspector; and
- not allow tick infected (or suspected to be tick infected) stock to be moved and such stock must be isolated until authorised to be released by an Inspector.
- 11 At any reasonable time (without giving prior notice to the ATCP), an ATCP must allow an Inspector access to:
 - a. any property on which stock moved under an approved scheme are normally depastured; or
 - b. any register, record or documents in relation to such stock; and
 - c. any stock relevant to the approved scheme,

for the purposes of:

- d. inspecting, auditing and monitoring the property, register, record or any document and the stock;
- e. obtaining samples, including hair or blood from any stock, or sample of any acaricide involved or used in conjunction to an approved scheme; or
- f. enquiring the ATCP in relation to the property, register, record or any document and the stock.

12 An inspector may immediately suspend:

- a. an ATCP's approval if an inspector believes on reasonable grounds the ATCP or any person acting with the authority of the ATCP has moved stock contrary to the Notice or contravened any conditions of the approval; or
- an Organisation's accreditation if an inspector is satisfied that changes in the Organisation or its public liability policy no longer makes the Organisation eligible for accreditation with the DPI&F.

13 An Inspector must:

- a. notify the ATCP and the Organisation of the suspension in writing and provide grounds for the suspension; and
- b. inform the ATCP or the Organisation (as the case may be) that he, she or it (as the case may be) has 28 days after the date of the suspension notice to show grounds why the approval should not be cancelled. The ATCP's or the Organisation's (as the case may be) submission must be in writing to the Chief Inspector.
- 14 An approval is cancelled if the ATCP or the Organisation (as the case may be):
 - a. has not within 28 days of the date of the suspension notice made a written application to the Chief Inspector; or

- b. the Chief Inspector is not reasonable satisfied with the ATCP's or the Organisation's submission (as the case may be).
- 15 If the approval is cancelled, the Chief Inspector must notify the ATCP and the Organisation in writing. In the written notice, the Chief Inspector must inform the ATCP or the Organisation (as the case may be) of his, her or its rights (as the case may be) to appeal to the Magistrates Courts under section 36 of the *Stock Act 1915*.
- 16 This Agreement automatically terminates three (3) years after the ATCP and the Organisation are notified in writing of the approval, unless sooner terminated by the Chief Inspector or renewed after the ATCP or the Organisation's request in writing to the Chief Inspector no later than 30 days prior to the expiration of the Agreement.

We declare that we agree to adhere to all conditions or instructions of the Chief Inspector of Stock as outlined in the Schedule of Conditions.
